

**May 29, 2020 UPDATE
REGARDING COVID-19**

Dear Residents and Families,

As a five-star retirement community, our top priority has always been the health and safety of our residents, families, visitors and staff. Lakeview is following guidance from multiple governmental agencies including the United States Centers for Disease Control (CDC), the United States Centers for Medicare and Medicaid Services (CMS), the Kansas Department of Health and Environment (KDHE), the Kansas Department of Aging and Disability Services (KDADS) and the Johnson County Department of Health and Environment (JCDHE).

CMS has issued regulatory guidance for nursing homes that required reporting of COVID-19 test results in residents and employees. Below is a table of current results with the change from week to week displayed beside the total number (+/-#):

There has been little change in our COVID-19 statistics since last Friday. We have tested 41 residents, 31 have been negative and 10 positive with the last positive case on March 30th (60 days ago). On the employee front, we have tested 41 and 40 were negative with 1 still pending. Our licensed areas (CC, ET, AL) continue to not have any in-house acquired cases of COVID-19. The extraordinary efforts by everyone continue to keep all that live and work here at Lakeview safe and healthy.

While our campus remains COVID free, the virus is still affecting several senior living communities in Johnson County. We want Lakeview staff and residents to continue doing their part to protect our community. Here are a few items you can do to help keep our Lakeview community safe:

- We encourage Lakeview residents to stay on the Lakeview campus
- Practice social distancing by maintaining 6' between yourself and others
- Always wear a mask when you are outside your residence or office
- Avoid congregating in the hallways or walkways
- Cover your mouth and nose when you cough or sneeze
- Wash your hands for 20 seconds with soap and water
- Use hand sanitizer whenever soap & water are not available



Lakeview has a multi-phase approach to reopening the campus. Here is a brief update on status:

Open:

- Outpatient Therapy
- Indoor & outdoor walking provided you wear a mask
- Garden Plots
- Monthly IL housekeeping
- Common area spaces on each floor of the high-rise buildings opened to 4 unrelated residents per table and tables must be 6' apart. When using the common areas, please wipe down the touch surfaces before and after use. Also, please log your time start and stop time on the log provided. Through contact tracing we can quickly isolate those who may have been exposed and prevent others from being exposed.
- The Art Studio in Northpointe is open to 4 unrelated artists at a time.
- The Woodshop in Heritage Place is open to 2 unrelated woodworkers at a time.
- Eastside Terrace (744-2306) & Heritage (744-2497) Beauty Shops are open for cuts by appointment only. We will only be able to do one person at a time and no waiting.
- IL residents can meet visitors outside provided the resident and visitors wear masks, practice social distancing of at least 6 feet, and limited to less than 5 people. We encourage those visitors to be screened at one of the front entry screening areas to help protect everyone's safety. In the last 14 days the visitors must not have traveled to or be coming from one of the following states: New York, New Jersey, Connecticut, Rhode Island, Massachusetts, Illinois, or Maryland and also, must not have travelled internationally or on a cruise ship in the last 14 days.

Still closed (not an inclusive list):

- Dining Rooms – Meals will continue to be delivered to your apartment doors
- Bistro & coffee lounges in Heritage, Northpointe and Southridge
- Bus transportation / shuttles
- **No** inside visitors except for medical assistance
- Gym and exercise areas in Eastside Terrace, Northpointe and Southridge (still awaiting disinfecting chemicals that will not harm the sensitive exercise equipment)
- Pool – Eastside Terrace Aquatic Center
- Gathering / entertainment areas – Heritage Activity Center & Southridge Treetop
- Group activities and living well classes
- Non-essential travel
- **NO VISITORS** in the licensed areas of Centerpointe Care Center, Eastside Terrace Short-Stay Rehab and Eastside Terrace Assisted Living. This is per federal CMS regulation and cannot be overridden by state, county or local reopening plans.

Lakeview's reopening plan will be slower than the state and county plans out of an abundance of caution. Given that COVID-19 is still affecting senior living communities all around us, we must be very cautious about our reopening. Please remember the safety measures we put in place are there to protect you, your neighbors, staff and the Lakeview community as a whole.
